## The Fleck Effect™ 2018 NAILE Show

---

The Fleck Effect™ show will immediately follow the conclusion of the FSFF Pinnacle Show in Broadbent Arena using the same judge and will be open to Simmental cattle other than Fullblood Simmentals and **must contain a minimum of 25% Fleckvieh Simmental genetics**.

The remaining percentage can be a mix of any other breed(s).

Arrival schedule: November 8th, 12p (Noon) through November 9th, 12p (Noon)

FSFF check-in will be in the FSFF stalling area; date & time to be announced.

### **GET OF SIRE:**

Two animals by the same sire. Either or both sexes represented. Animals must be shown in individual classes. May be owned by multiple exhibitors.

### **PRODUCE OF DAM:**

Two animals by the same dam. Either or both sexes represented. Animals must be shown in individual classes. May be owned by multiple exhibitors.

### **BREEDER'S HERD:**

Four animals bred by one exhibitor. Both sexes represented. Animals must be shown in individual classes. May be owned by multiple exhibitors.

### **PREMIER EXHIBITOR & PREMIER BREEDER:**

Where a herd is registered in the names of different members of a family, residing on one farm and when the herd is one unit, all entries may be considered as a single exhibitor for Premier Exhibitor and Premier Breeder classes.

The Premier Exhibitor & Premier Breeder awards will be determined by a 10 point system. If there are 10 or more entries in the class, first place will receive 10 points, second place 9 points, etc., through tenth. If there are less than 10 entries, first place will receive points equal to the number in the class. Class totals will be determined from the total number of animals entered in a class from the official class sheets.

In the event of a tie, the exhibitor or breeder winning the most first place awards will receive the award. If the tie still exists, the one with the most second place awards will win. If necessary, this process will continue until the tie is broken.

### **Premier Exhibitor:**

Exhibitor must own the animals. When animals are owned in partnership, each unique partnership is considered a unique exhibitor.

The exhibitor winning the most points shall be designated the Premier Exhibitor. In classes with ten or less animals, no more than two head per exhibitor will be counted toward premier points.

### **Premier Breeder:**

The owner of the dam at the time of service shall be considered the breeder of the animal. For animals bred in partnership, each unique partnership is considered a unique breeder.

The breeder winning the most points shall be designated Premier Breeder. In classes with ten or less animals, no more than two head per breeder will be counted toward premier points.
